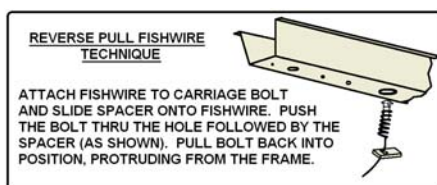
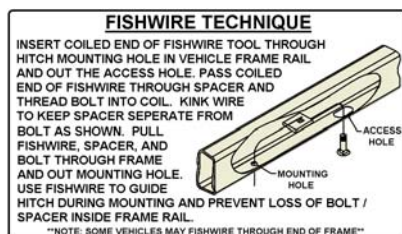

MUFFLER HEAT SHIELD TRIMMING DIAGRAM

INSTALLATION STEPS

1. Remove plastic underbody panel on the passenger side. Remove the underbody panel by removing (2) screws, (2) plastic push fasteners and (1) nut. (**Note:** Plastic push fastener is removed by prying head down with a small screwdriver, pinching opposite end and pushing down through hole.)
2. Lower the exhaust by removing the (1) nut securing the rearmost exhaust hanger brackets to the driver side frame rail. Remove the (2) bolts securing the exhaust hanger bracket near the cross member, and the (1) bolt from the exhaust hanger forward of the muffler.
3. Remove the muffler heat shield from the vehicle by removing the (4) nuts securing it. Trim the heat shield to allow access to the existing holes in the frame rail. (See Muffler Heat Shield Trimming Diagram.)
4. Reinstall the heat shield removed in Step 3.
5. Fishwire a **1/2-13 x 1 1/2"** carriage bolt and CM-SP19 spacer into each of the forward holes as shown. (See Fishwire Technique.)
6. Reverse pull fishwire a **1/2-13 x 1 1/4"** carriage bolt and CM-SP19 spacer into each of the rearmost holes as shown. (See Reverse Pull Fishwire Technique.)
7. Raise the hitch into position, taking care not to push the fishwired hardware into the frame rails. Place a CM-SP40 between the side plate and frame rail passing the forwardmost bolt through both the spacer and the side plate. Secure the hitch to the frame rails with the hex flange nuts as shown.
8. Torque all 1/2" hardware to 75 ft-lbs.
9. Trim the underbody panel as required to reinstall panel with hitch installed.
10. Raise the exhaust into position and reinstall the fasteners for the exhaust hangers removed in Step 2.
