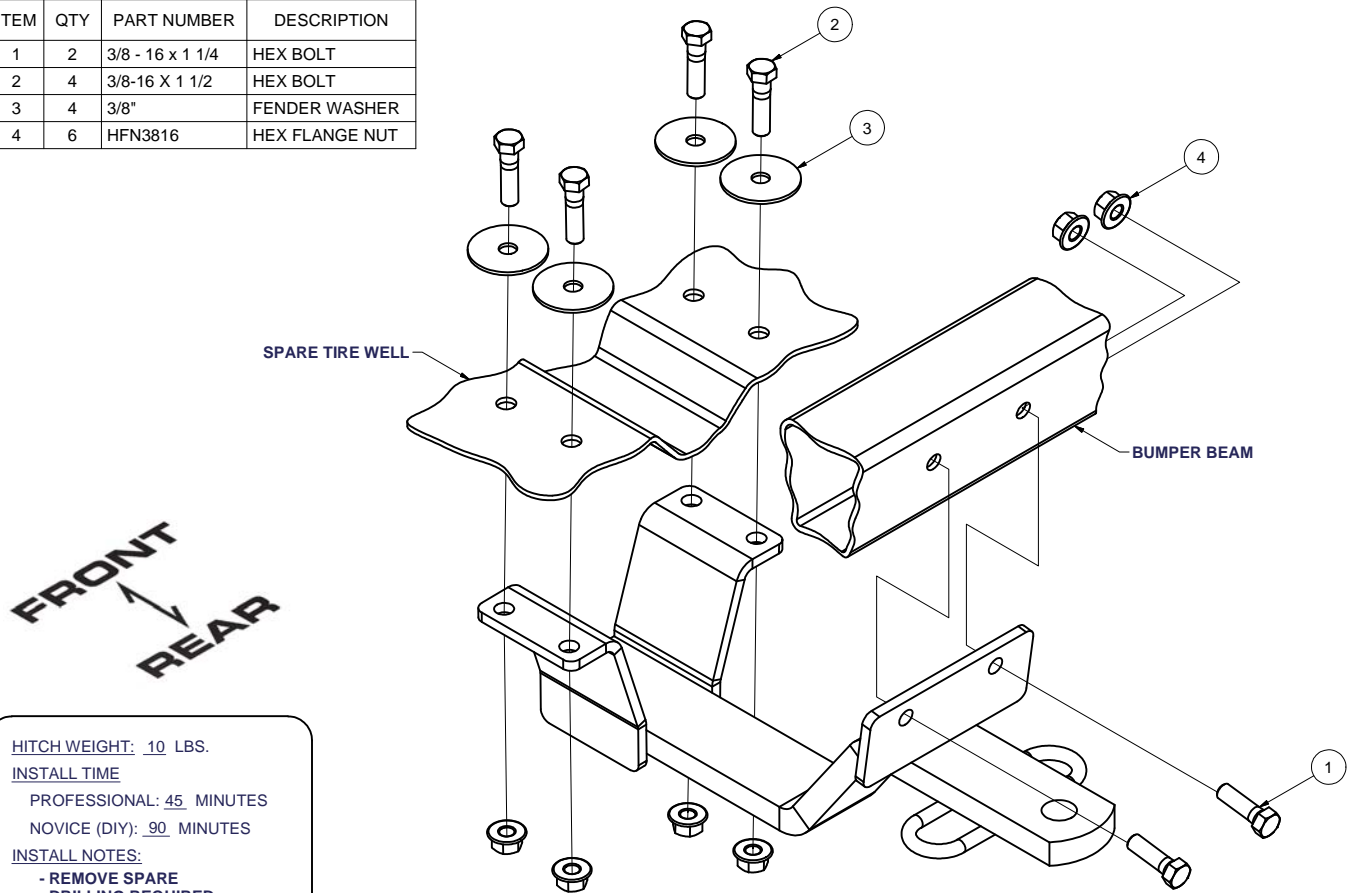

## INSTALLATION STEPS

1. Remove the fasteners from the hitch. Temporarily remove the vehicle's spare tire. Measure and mark the vehicle center line on the rear bumper.
2. A small piece of the rear bumper cover must be cut away. Remove a strip 6 inches long (3 inches on each side of center line) by 1 inch high next to the metal strip at the bumper bottom retaining cover.
3. Position the hitch centered and square with the vehicle, against the steel part of the bumper and spare tire well as shown. Use the hitch as a template to mark the bumper and spare tire well (6) places for 3/8" bolts. Center punch and drill these holes.
4. Bolt the hitch to the bumper using hardware as shown. On NX model, the flexible panel may have to be moved or a small piece cut away to get wrench access to bumper fasteners. Bolt the hitch at the spare tire well using fender washers inside the spare tire well.
5. Torque all 3/8" fasteners to 30 lb-ft.
6. Use silicone sealant to seal hardware installed through spare tire well.
7. Reinstall spare tire.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
