The limited warranty applies to tires purchased after March 1, 2016.
The limited warranty applies to tires purchased after October 1, 2013.

Delinte Limited Tire Warranty

This limited warranty only applies to the original purchaser of select Delinte brands indicated in the warranty chart of this document. Only tires installed on the original vehicle which have been installed according to the manufacturer's recommendation are eligible.

The limited warranty applies to tires purchased after March 1, 2016. Tires purchased before March 1, 2016 are subject to the previous published warranties.

This limited warranty covers defects in materials and workmanship, limited mileage warranty, road hazard warranty, and road hazard replacement (select tires only).

A. Warranty Length

A tire will be required to have at least 2/32" of usable tread life remaining. Any tire having less than 2/32" tread is considered past the usable tread life and not warrantied.

B. Materials and Workmanship Warranty

Select Delinte brands (indicated in the warranty chart of this document) are warranted against defects in materials and workmanship and will be replaced free of charge within the first 2/32" wear of original usable tread life, or within 6 months from the period of purchase, whichever comes first.

After the 100% replacement term expires and the tire is still within 60 months from the manufacturing date, credit will be determined by the percentage of original tread depth remaining on the tire. Any additional costs of mounting, balancing, installation charges, and any applicable sales tax or use taxes are not covered.

C. Limited Mileage Warranty

Select Delinte brands (indicated in this document) are manufactured to protect against premature tread wear. If a tire reaches the end of its usable tread life (2/32") before the stated mileage warranty (indicated in this document) the original purchaser will be issued a comparable Delinte Tire brand manufactured by the Century Tire factory on a pro-rata basis, based on the percentage of remaining usable tread depth down to the remaining 2/32" tread depth. Tread must be worn down evenly across the face of the tread.

In order to maintain this limited warranty, all tires must be rotated at least every 3-4,000 miles. Any additional costs of mounting, balancing, installation charges, and any applicable sales tax or use taxes are not covered.

Documentation is required showing date of installation and removal to maintain tread wear warranty.

If different tire sizes are installed (staggered tire sizes) on the front and rear, the tire warranty will be 50% of the stated mileage warranty published in the summary of limited tire warranty coverage by the tread pattern chart. Tires **MUST** be rotated side-to-side every 3-4,000 miles. Tread must be worn down evenly across the face of the tread.

D. Exclusions Not Covered Under This Limited Warranty

- **Tires used on RVs (recreational vehicles), Motor Homes, Trailers, or tires used in commercial service.**
- **Any tire that has any brand information, sizes, or the D.O.T. identification numbers removed intentionally.**
- **Ride complaints after the first 2/32" of tread wear or replacement of 3 or more tires from the same vehicle will not be accepted.**
- **Premature/irregular wear due to vehicle mechanical deficiencies.**
- **Failure to rotate the tires at recommended intervals.**
- **Road hazard damage including cuts, snags, bruises, punctures, tire repair, impact breaks, etc. (Select tires indicated in this document have coverage under the Delinte Tire Road Hazard Policy.)**
- **Any tires on any vehicle that are registered and normally operated outside the U.S.**
- **Any damage from over/under inflation, tire overloading, fire, theft, and any defective mechanical condition of the vehicle.**
- **Any damage from incorrect tire mounting/dismounting/balancing, any incorrect tire application, water or any other material trapped inside the tire during tire mounting.**
- **Any racing or other misapplication of tire to improper road conditions.**
- **Environmental ozone or weather cracking after 48 months from tire manufacture date.**
- **Any accident, fire, chemical corrosion, tire alteration, vandalism, abuse, or running on a flat tire.**
- **Any tires worn beyond the tire bar wear indicators and less than 2/32".**
- **Uneven wear in which the tread groove difference is 2/32" or more across the face of the tire.**
- **Any loss of time or use, inconvenience, any incidental or consequential damage.**
- **Flat spotting caused by improper storage or brake lock.**

E. Road Hazard Warranty

This road hazard program is offered for select Delinte tires (listed in summary of limited tire warranty chart) for non-repairable tread damage (based on RMA guidelines) based on the following limitations:

- If road hazard damage occurs in the first 6 months from the date of purchase OR the first 2/32" of tread life, (whichever comes first), Delinte will replace with a comparable tire manufactured by the Sentury Tire factory 100% free of charge.
- If road hazard damage occurs in the first year from the date of purchase OR from 2/32" to 4/32" tread life (whichever comes first), Delinte Tire dealer will reimburse the consumer 50% of their original retail cost. Dealer or distributor credit is based on the percentage (%) of their buying price. Tread must be worn down evenly across the face of the tread.

(A prorated credit will apply to the replacement tire based on the tread depth of the original Delinte tire.)

Any additional costs of mounting, balancing, installation charges, and any applicable sales tax or use taxes are not covered. Road hazard coverage applies only to the original purchaser and is not transferable. Road Hazard program is effective March 1, 2016.

The following tire exclusions do not apply to the Road Hazard Warranty:

- **Vandalism damage**
- **Vehicle accident damage**
- **Repairable under Rubber Manufacturers Association (RMA) guidelines**
- **Commercial use damage**
- **Racing or off road use damage**
- **Snow chains or studs damage**
- **Mechanical wear damage**
- **Tires transferred to another vehicle**
- **Tires that reflect damage due to continued run flat or acute under-inflation**



F. Owner's Claim Filing Obligations

To file for a Limited Warranty and Road Hazard Warranty Claim, the owner must:

- Present the Limited Warranty Registration Form to an authorized Delinte Tire dealer for processing. Please keep a copy for your own records.
- Submit a copy of the original purchase receipt including automobile mileage at time of tire installation and of tire dismounting.
- Submit a tire rotation record showing that all tires have been rotated every 3-4,000 miles. Tire rotation submission is not necessary for the Road Hazard Warranty.

G. TIRE MAINTENANCE GUIDELINES

To reduce the risk of tire failure we recommend the following:

- Maintain proper inflation pressure based on vehicle manufacturers recommendation.
- Do not drive if tires are under/over-inflated. Pressure should be set at the level recommended by the vehicle manufacturer.
- Wheel alignment and balancing should be maintained based on vehicle manufacturer recommendations.
- Do not overload. The maximum load carrying capacity is molded on the tire sidewall.
- Avoid potholes and driving over curbs, obstacles, and pavement edges.
- Avoid excessive spinning of tires.
- Tires must be replaced when only 2/32" tire tread depth remain.
- Check tires frequently for scrapes, cuts, foreign objects, separations, or bulges. If damage is found, change tire immediately with a spare and have the damaged tire examined by a Delinte Tire dealer professional.
- Maintain proper speed limits allowed by law or the appropriate speed justified by driving conditions.
- Rotate tires to achieve maximum longevity.

Sentury Tire Americas Limited Warranty

Effective October 1, 2013

I. Tires Covered by this Warranty:

This limited warranty applies to Century Tire Americas brand Delinte brand tires bearing the complete description and serial number as required by the DOT. The warranty applies only to new tires purchased after October 1, 2013. New tires purchased before that date are subject to previous published warranties. This warranty is effective only to new tires for which claims are made within five years of date of production, based on the tire DOT serial number.

II. What is Warranted and For How Long:

A. Material and Workmanship Warranty:

1. Every Century Tire Americas Brand radial tire is warranted against defects in material and workmanship for the usable life of the original tread, ending at the appearance of the tread wear out indicators at 2/32" remaining tread depth.
2. If a tire becomes unserviceable due to such defect within the first 2/32" of wear; it will be replaced free of charge with a comparable Century Tire Americas Brand.
3. After the first 2/32" wear, a prorated adjustment credit to the customer will be given based on the percentage of remaining usable tread depth, down to the remaining 2/32" wear bars, at which point no credit is due.
4. OUT-OF-ROUND or OUT-OF-BALANCE claims will be accepted for adjustment only during the first 1/32" of the original tread depth, and tires will be replaced free of charge with comparable Century Tire Americas. A set of four (4) tires from the same vehicle will not be accepted for out-of-round or out-of-balance claims.

B. Limited Mileage Warranty:

Sentury Tire Americas Brands are warranted to achieve the following mileages before becoming worn out at 2/32" remaining tread depth.

Prorated adjustment credit will be given based on percentage of mileage not achieved. This mileage warranty is applicable only for normal highway use when all of the Owner's Obligations listed below are met.

III. What is Not Covered (Exclusions)

- A. Unserviceable tires due to road hazard damages (cuts, snags, punctures, bruises, impact breaks, etc.) improper repair technique or materials, improper inflation, overload, irregular wear, wheel imbalance, defective vehicle mechanical components (brakes, suspension wheels, etc.), improper suspension alignment, accident, fire, chemical damage, damage from chain use, racing, off-road use, runflat, improper installation, vandalism or abuse.
- B. Tires on any vehicle registered and normally used outside the 50 United States, Puerto Rico and Canada.
- C. Tires presented for warranty claim by other than the original purchaser, or tires that were transferred to another vehicle from the one upon they were originally installed, regardless of by whom. This warranty is not transferable.
- D. Any tires whose failure is caused by any previous damages or repairs.
- E. The Mileage Warranty is not applicable if tires are used in commercial service, or determined at our discretion, to have premature or irregular wear due to abusive service or defective vehicle conditions. **(Abusive service includes off-road use, excessive mountain road driving, racing or passenger car tires on pick-up, RV, or utility vehicles.)**
- F. Mileage warranty does not apply to vehicles with staggered tire fitments.
- G. Tires that have Tread Siping or otherwise modified from the original design.
- H. Mileage warranty does not apply to vehicles with staggered set up tires.

IV. Owners Obligations:

At the time of purchase, the tire(s) must be properly installed, balanced and air pressure set to the vehicle manufacturer's specifications of original equipment size, or at an air pressure adequate to carry the vehicle load if it is a different replacement size. At least monthly, the owner must check tire pressure with a gauge and inflate to recommended cold PSI level. Do not rely on car servicers to perform checks. Tires must be rotated at least every 6,000 miles or earlier if unequal wear is occurring and proof of compliance must be recorded on the warranty card. Owner must have tires rebalanced if vibration is experienced and alignment must be checked if unequal or rapid wear is occurring, or when scheduled by the vehicle maker.

All warranty claims must be presented to an **authorized Sentury Tire Americas dealer**. Tire owners must present their warranty card verifying mileage, proof of date and place of purchase, to make a Mileage Warranty claim.

V. Legal Rights:

ALL IMPLIED WARRANTIES, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, SHALL BE LIMITED IN DURATION TO THE ABOVE PERIOD. TO THE EXTENT PERMITTED BY LAW, SENTURY TIRE AMERICAS CORPORATION SHALL NOT BE RESPONSIBLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SUCH AS LOSS OF USE OF THE TIRE OR THE VEHICLE ON WHICH IT IS USED, INCONVENIENCE, OR COMMERCIAL LOSS. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS OR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS, WHICH VARY FROM STATE TO STATE. THIS IS THE ONLY EXPRESS WARRANTY APPLICABLE TO SENTURY BRAND TIRES AND SUPERSEDES THE TERMS OF ANY PREVIOUS WARRANTY. SENTURY NEITHER ASSUMES NOR AUTHORIZES ANYONE TO MAKE OR ASSUME IT FOR ANY OTHER WARRANTY.
