Section 2. Hazards identification

General

Section 5. Fire-fighting measures

Extinguishing media

Suitable extinguishing

Specific hazards arising from the chemical

: Highly flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. Section 7. Handling and storage

Precautions for safe handling

Protective measures
