**READ THESE INSTRUCTIONS CAREFULLY BEFORE STARTING:** For the ease of installation, your vehicle must be raised a minimum of 36". **Warning:** Should you decide to install any exhaust yourself, be warned that the original equipment jack that came with the vehicle is intended for emergency use only. The use of a frame jack in conjunction with a floor jack as main support is highly recommended to minimize the accidental dropping of a vehicle while the installation proceeds. Never go under any vehicle that is supported by a bumper jack!

When installing the WARLOCK™ "Bypass" series racing mufflers on any 1986-1993 Mustang, you must shorten the front intermediate pipes 4¾" to 5" and install the mufflers forward to line up the rod hangers and allow for access to remove the "flow intensifier".

**There should be 5" between the rear-end balancing weight and the back edge of the muffler case.**

**NOTE:** Because you have moved the mufflers forward, it may be necessary to add tubing or to modify the front section of your tailpipes to install them in the muffler outlets.

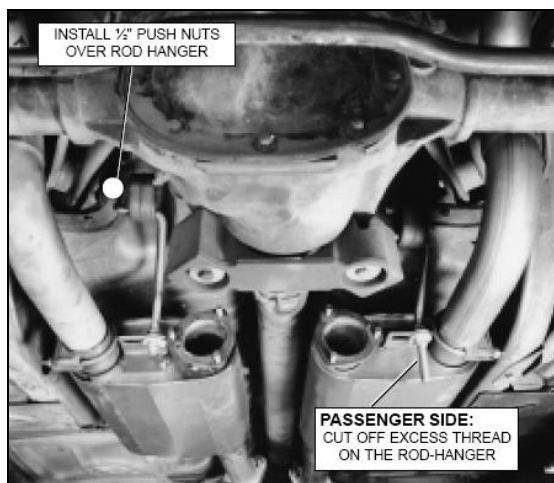
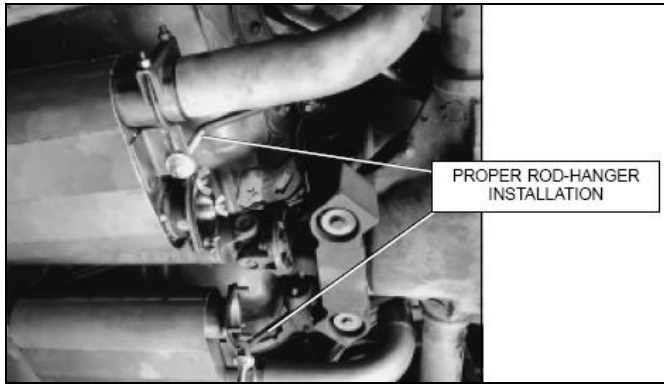
