LIMITED WARRANTY

Prestige Autotech Corporation warrants to the original retail or first customer purchaser that its wheels will be free of defects in coatings and workmanship under normal and reasonable use for one year from the date of purchase. Prestige Autotech Corporation further warrants to the original retail or first customer purchaser that its wheels will be free of structural defects for the lifetime of the product.

Prestige Autotech Corporation's obligation under these warranties is limited to the repair or, at Prestige Autotech Corporation's option, replacement without charge, except for transportation, of any wheel, which in Prestige Autotech Corporation's opinion is defective in material and workmanship. Such repair or replacement shall not include installation.

THE ABOVE WARRANTIES SHALL NOT APPLY TO:

1. Any defect, malfunction or failure caused by damage in transit, or by abuse, accident or negligence.
2. Wheels that are damaged or suffer structural failure as a result of off-road activities that exceed their rated load.
3. Wheels that have been altered or repaired.
4. Wheels that have not been installed in accordance with Prestige Autotech Corporation's instructions or installed on incorrect tire sizes or used with excessive vehicle loads.
5. Wheels that have been installed with other than Prestige Autotech Corporation's approved accessories such as center caps, lug nuts, hub rings, etc.
6. Wheel corrosion or cosmetic flaws occurring after purchase due to car damage, chemicals, caustic cleaning agents, climate conditions or neglect.
7. Appearance defects in wheels that have been mounted after purchase or have been sold as a blemished product
8. Wheels made to fit with the use of spacers or adapters.
9. Plated wheels with bare spots on the inside or back due to rack contacts and gas pockets.

The Prestige Autotech Corporation's Warranties are valid only for a wheel(s) purchased in the U.S. and Canada and when the wheel is returned to the authorized dealer from whom it was purchased, freight prepaid by the consumer purchaser together with proof of purchase. There is no warranty that the wheel is merchandisable or satisfactory for any purpose except such as in recommended in the Prestige Autotech Corporation's printed application guides; nor, is there any warranty expressed or implied, except such as is set herein.

THE WARRANTIES ARE THE SOLE AND EXCLUSIVE WARRANTIES GIVEN WITH RESPECT TO THE WHEELS AND ALL OTHER EXPRESS WARRANTIES ARE HEREBY EXCLUDED. NEITHER PRESTIGE AUTOTECH CORPORATION NOR AN AUTHORIZED PRESTIGE AUTOTECH CORPORATION DEALER WHO SELLS THE WHEELS IS RESPONSIBLE FOR INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES.
