


## Instructions

# Model PL 8521 for the TOYOTA TACOMA with and w/o camera, '05 and up

Parts Included:


Power Tailgate Lock Unit Short Wiring Cable Long Wiring Cable Cable Ties Blue Connector Tap

## **Tools Required:**

10 MM Socket T-30 Torx driver Pliers

### Installation:

- 1. Lower the tailgate and remove the access panel using a T-30 Torx driver to undo the 15 bolts.
- 2. Release the driver's side rod end and the mounting screw on the driver's side with a 10 MM socket.
- 3. Place the POWER LOCK inside the tailgate on the driver's side as shown below.
- 4. Insert and tighten the mounting bolt with a 10 MM socket to secure the POWER LOCK. Re-connect the rod end.



- 5. **Wiring:** Feed the round bullet connectors on the end of the short wiring cable into a drain hole at the bottom of the tailgate and up the tailgate to the handle opening. Connect them to the wires of the POWER LOCK. Feed the other end into the gap between the bumper and the truck bed and connect it to the long wire harness. Locate the connector so that you can reach it to remove the tailgate. Coil and tie the extra length of the short wiring harness inside the tailgate. Don't attach it to the truck.
- 6. Route the long wire harness along the frame rail on the driver's side of the truck and up the firewall inside the engine compartment to the grommet of the wire harness on the driver's side of the firewall..
- 7. Pull the wires through the grommet into the cab.
- 8. **2005-2007: 2 door models** remove the driver's side kick panel inside the cab and locate the wire harness leading to the driver's side door. Locate the Blue/Pink and the Blue/White wires. Attach the two blue wire taps to them and squeeze them shut with with a pair of pliers.
  - 4 door models run the wires up and into the driver's side rear step plate and into the 'B' pillar. Wire colors are as above.

2008 models - locations are as above, however wire colors are Blue/pink striped and Blue/red striped.

2010 & Up - locations are as above, however wire colors are Blue/red and blue/black.

- 9. Connect the long wiring harness to the blue wire taps and test the system. Lock and unlock the doors using the power door lock switch. The locking bolt of the power tailgate lock should slide below the flange of the scissor link and lock and unlock it. Reverse the wiring if the operation is out of phase.
- 10. Coil and tie the excess wiring harness and attach the harness to the underside of the truck with the cable ties. Make sure it isn't chafing on the springs or shocks and isn't touching any part of the exhaust sytem.
- 11. Perform a final check to see that the POWER LOCK is functioning properly and replace the access panel and the kick plate to complete the installation.
