4. First-aid measures

6. Accidental release measures

Prevent entry into waterways, sewer, basements or confined areas. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. 7. Handling and storage

Do not allow backfeed into the container. Purge air from system before introducing gas. Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Contact your gas supplier if in doubt. Do not re-use empty containers. Do not breathe mist or vapor. Do not taste or swallow. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure.
